

SEPTEMBER HIGHLIGHTS

- September brought forth much of the same pain as did August – albeit more acutely – as financial markets continued to contend with the concept of more stringent central banks. The US Federal Reserve (Fed) and the European Central Bank (ECB) both raised rates by 75 bps, and the Bank of England (BOE) raised by 50 bps. These are significant, if not historic, increments for the institutions; as a result, financial markets felt their ensuing tremors all too well.
- The derivative effects of such tightening policies have garnered significant attention. Growth, for example, has become a mixed bag in the US, as many market participants are beginning to fear that the Fed will instigate a recession.

 While headline inflation finally showed signs of easing, the core rate still accelerated an astounding 6.3% in the month of August. US manufacturing sentiment deteriorated, but the labor market remained tight suggesting that the Fed's job is still unfinished. Geopolitical tensions rumbled on as the further escalation of the Russia-Ukraine war added stress to the European energy situation, and unfunded UK government spending plans required emergency BOE intervention in an effort to mitigate systemic risk.
- For the second consecutive month, equities were largely in the red; but in September, the extent to which they were could be quite dramatic. The MSCI EM index which represents the performance of emerging market equities fared amongst the worst, returning -11.72%. China weighed on the index and the US dollar again appreciated for much of the month both contributed to this outcome. International developed large cap companies, as measured by the MSCI EAFE index, were marginally better off, generating -9.35% in returns. The S&P 500, which tracks US large-cap companies, was similarly wrecked, as it returned -9.21%.
- The hawkish US Federal Reserve continues to surprise market participants. US Treasury bonds as exemplified by the Bloomberg US Treasury index returned -3.45% in September, as the 10-year yield rocketed by 64 bps on the month to 3.83%. US corporate bonds, as tracked by the Bloomberg Corp Bond index, were even worse off, returning -5.26%. These products can be impacted by domestic equity performance. Mortgage-backed securities, as tracked by the Bloomberg Securitized MBS index, produced a troubling -4.88% in returns, suggesting that the housing market is beginning to feel the effects of rising rates.
- Despite persistent geopolitical challenges, oil maintained its cheapening trend in September. It closed at a price of \$79.49 on the final day of the month, thereby returning -11.23%. The US dollar gained against the Euro and the Japanese Yen, returning 2.51% and 4.16%, respectively.



INDEX DESCRIPTIONS:

BBgBarc EM Hard Currency Aggregate: Covers countries and sectors of the emerging markets fixed income investment universe, which includes USD-denominated emerging markets corporate and government-related debt.

BBgBarc Global Agg. ex-U.S. Dollar: Measures changes in global investment-grade, fixed-rate debt markets. It combines non-U.S. dollar-denominated versions of the Pan-European Index and the Japanese, Canadian, Australian and New Zealand components of the Global Treasury Index.

BBgBarc U.S. Aggregate Bond Index: Measures changes in the fixed rate debt issues rated investment grade or higher by Moody's Investors Service, Standard and Poor's, or Fitch Investor's Service, in that order. The Aggregate Index is comprised of the Government/Corporate, the Mortgage-Backed Securities, and the Asset-Backed Securities indices.

BBgBarc U.S. Corporate Investment Grade: A component of the U.S. Credit index. Publicly issued U.S. corporate and specified foreign debentures and secured notes that meet the specified maturity, liquidity, and quality requirements. To qualify, bonds must be SEC-registered.

BBgBarc U.S. Government: The U.S. Government component of the U.S. Government/Credit Index comprised of securities issued by the U.S. Government; also including public obligations of the U.S. Treasury with remaining maturity of one year or more, and publicly issued debt of U.S. Government agencies, quasi-federal corporations, and corporate or foreign debt guaranteed by U.S. Government. Must be a publicly issued, dollar-denominated and nonconvertible. Must be rated investment-grade (Baa3/BBB- or higher) by at least two of the following rating agencies: Moody's, S&P, Fitch; regardless of call features, have at least one year to final maturity, and have an outstanding par value amount of at least \$250 million.

BBgBarc U.S. High Yield 2% Issuer Cap index: Issuer-constrained version of the flagship U.S. Corporate High Yield Index, which measures the USD-denominated, high yield, fixed-rate corporate bond market. The index follows the same rules as the uncapped version, but limits the exposure of each issuer to 2% of the total market value and redistributes any excess market value index wide on a pro rata basis.

BBgBarc U.S. Municipal Bond Index: Covers the USD-denominated long-term tax exempt bond market. The index has four main sectors: state and local general obligation bonds, revenue bonds, insured bonds, and prerefunded bonds local general obligation bonds, revenue bonds, insured bonds.

BBgBarc U.S. Securitized: The index is a composite of asset-backed securities, collateralized mortgage-backed securities (ERISA-eligible) and fixed rate mortgage-backed securities.

BBgBarc U.S. Treasury: A component of the U.S. Government Index. Must be publicly issued, dollar-denominated and non-convertible, fixed rate (although it June carry a coupon that steps up or changes according to a predetermined schedule) U.S. Treasury security. Must be rated investment-grade (Baa3/BBB- or higher) by at least two of the following rating agencies: Moody's, S&P, Fitch; regardless of call features, have at least one year to final maturity, and have an outstanding par value amount of at least \$250 million.

Bloomberg Commodities Index: Provides a diversified representation of commodity markets as an asset class. The index is comprised of exchanged-traded futures on physical commodities; representing 20 commodities which are weighted for economic significance and market liquidity. To promote diversification, weighting restrictions are placed on individual commodities and commodity groups.

MSCI EAFE (Europe, Australasia, Far East): A free float-adjusted market capitalization index that is designed to measure developed market equity performance, excluding the United States and Canada. The EAFE consists of the country indices of 21 developed nations.

MSCI EAFE Growth: Represents approximately 50% of the free float-adjusted market capitalization of the MSCI EAFE index, and consists of those securities classified by MSCI as most representing the growth style.

MSCI EAFE Small Cap: Offer an exhaustive representation of this size segment by targeting companies that are in the Investable Market Index but not in the Standard Index in a particular developed market. The indices include Value and Growth style indices and industry indices based on the Global Industry Classification Standard (GICS).

MSCI EAFE Value: Represents approximately 50% of the free float-adjusted market capitalization of the MSCI EAFE index, and consists of those securities classified by MSCI as most representing the value style.

MSCI Emerging Markets: A free float-adjusted market capitalization index that is designed to measure equity market performance of emerging markets. As of July 2, 2014, the index consists of the following 23 emerging market country indices: Brazil, Chile, China, Colombia, Czech Republic, Egypt, Greece, Hungary, India, Indonesia, Korea, Malaysia, Mexico, Peru, the Philippines, Poland, Qatar, Russia, South Africa, Taiwan, Thailand, Turkey, and the United Arab Emirates.

Russell 2000: Measures the performance of the 2,000 smallest companies in the Russell 3000 Index, which represent approximately 10% of the total market capitalization of the Russell 3000 Index.

Russell Mid-cap: Measures the performance of the 800 smallest companies of the Russell 1000 Index, which represent approximately 31% of the total market capitalization of the Russell 1000 Index.

Standard & Poor's 500 (S&P 500): Measures changes in stock market conditions based on the average performance of 500 widely held common stocks. Represents approximately 68% of the investable U.S. equity market.

The Dow Jones Global Select REIT Index: Intends to measure the performance of publicly traded real estate securities. The indices are designed to serve as proxies for direct real estate investment, in part by excluding companies whose performance June be driven by factors other than the value of real estate. This index represents equity real estate investment trusts (REITs) and real estate operating companies (REOCs) traded globally.

DEFINITIONS:

Small-cap stocks refers to a company's capitalization as determined by the total market value of its publicly traded shares.

Large-cap stocks are generally defined as those with market capitalizations of more than \$10 billion.

Energy sector is a category of stocks that relate to producing or supplying energy.

Commodity is a basic good used in commerce that is interchangeable with other commodities of the same type. **Commodities** are most often used as inputs in the production of other goods or services.

Fixed income is a type of investment in which real return rates or periodic income is received at regular intervals and at reasonably predictable levels.

High-yield bond is a high paying bond with a lower credit rating than investment-grade corporate bonds, Treasury bonds and municipal bonds.

International: This asset class represents managers that seek long term capital appreciation by investing primarily in companies outside of the United States, including emerging markets in some instances. Companies of all cap sizes June be considered.
