

#### **OCTOBER HIGHLIGHTS**

- While October is a month notorious for its terrors, investors traditionally associate it with a time to consider buying equities; oftentimes its conclusion marks the end of the most seasonally painful portion of the year. Of course, very little in this post-Covid-19 world regime has retained any form of predictability, and as such, this most recent month was accompanied by atypical strength at least by recent standards in the equity market. Especially from a domestic perspective, equities surged to end the month following bouts of turbulence.
- While the geopolitical headwinds that have been confounding market participants through the entirety of this year remained intact, some of the economic news established a notion that the worst may already be in for financial markets a rhetoric that risk-conscious investors would be wise to heed cautiously. Irrespective of the investment implications, a fall in goods and energy prices, as reflected in the still-high September US CPI reading bodes well for the everyday American. Additionally, weakening PMI data in conjunction with a slowing housing market suggests that the room for continued aggressive tightening by the US Federal Reserve (Fed) may be shrinking. With that in mind, the Fed hiked by another 75 bps at the end of the month, and a robust labor market suggests that there are still many miles left on the path to policy normalization.
- As implied, October was most favorable to domestic equity markets. The S&P 500, which tracks US large-cap companies, returned a considerable 8.10%. International developed large-cap companies, as measured by the MSCI EAFE index, were a pace behind, generating 5.38% in returns. The MSCI EM index – which represents the performance of emerging market equities – still struggled, however, returning -3.10%. Uncertainty relating to changes in Chinese leadership weighed on the index, as well as the ever-determinative US dollar, which was rather mercurial on the month.
- The hawkish US Federal Reserve continued to surprise fixed income investors, albeit by a lesser margin in October. US Treasury bonds as exemplified by the Bloomberg US Treasury index returned -1.39% in September, as the 10-year yield rose by 27 bps on the month to 4.05%. US corporate bonds, as tracked by the Bloomberg Corp Bond index, were better off, returning -1.03%. These products can be impacted by domestic equity performance. Mortgage-backed securities, as tracked by the Bloomberg Securitized MBS index, produced a sluggish -1.43% in returns, suggesting that the housing market has been damaged by rising rates.
- Oil strengthened in October. It closed at a price of \$86.53 on the final day of the month, thereby returning 8.86%.
  The US dollar lost against the Euro but gained against the Japanese Yen, returning -0.82% and 2.74%, respectively.



#### INDEX DESCRIPTIONS:

**BBgBarc EM Hard Currency Aggregate:** Covers countries and sectors of the emerging markets fixed income investment universe, which includes USD-denominated emerging markets corporate and government-related debt.

**BBgBarc Global Agg. ex-U.S. Dollar:** Measures changes in global investment-grade, fixed-rate debt markets. It combines non-U.S. dollar-denominated versions of the Pan-European Index and the Japanese, Canadian, Australian and New Zealand components of the Global Treasury Index.

**BBgBarc U.S.** Aggregate Bond Index: Measures changes in the fixed rate debt issues rated investment grade or higher by Moody's Investors Service, Standard and Poor's, or Fitch Investor's Service, in that order. The Aggregate Index is comprised of the Government/Corporate, the Mortgage-Backed Securities, and the Asset-Backed Securities indices.

**BBgBarc U.S. Corporate Investment Grade:** A component of the U.S. Credit index. Publicly issued U.S. corporate and specified foreign debentures and secured notes that meet the specified maturity, liquidity, and quality requirements. To qualify, bonds must be SEC-registered.

**BBgBarc U.S. Government:** The U.S. Government component of the U.S. Government/Credit Index comprised of securities issued by the U.S. Government; also including public obligations of the U.S. Treasury with remaining maturity of one year or more, and publicly issued debt of U.S. Government agencies, quasi-federal corporations, and corporate or foreign debt guaranteed by U.S. Government. Must be a publicly issued, dollar-denominated and nonconvertible. Must be rated investment-grade (Baa3/BBB- or higher) by at least two of the following rating agencies: Moody's, S&P, Fitch; regardless of call features, have at least one year to final maturity, and have an outstanding par value amount of at least \$250 million.

**BBgBarc U.S. High Yield 2% Issuer Cap index:** Issuer-constrained version of the flagship U.S. Corporate High Yield Index, which measures the USD-denominated, high yield, fixed-rate corporate bond market. The index follows the same rules as the uncapped version, but limits the exposure of each issuer to 2% of the total market value and redistributes any excess market value index wide on a pro rata basis.

**BBgBarc U.S. Municipal Bond Index:** Covers the USD-denominated long-term tax exempt bond market. The index has four main sectors: state and local general obligation bonds, revenue bonds, insured bonds, and prerefunded bonds local general obligation bonds, revenue bonds, insured bonds.

**BBgBarc U.S. Securitized:** The index is a composite of asset-backed securities, collateralized mortgage-backed securities (ERISA-eligible) and fixed rate mortgage-backed securities.

**BBgBarc U.S. Treasury:** A component of the U.S. Government Index. Must be publicly issued, dollar-denominated and non-convertible, fixed rate (although it June carry a coupon that steps up or changes according to a predetermined schedule) U.S. Treasury security. Must be rated investment-grade (Baa3/BBB- or higher) by at least two of the following rating agencies: Moody's, S&P, Fitch; regardless of call features, have at least one year to final maturity, and have an outstanding par value amount of at least \$250 million.

**Bloomberg Commodities Index:** Provides a diversified representation of commodity markets as an asset class. The index is comprised of exchanged-traded futures on physical commodities; representing 20 commodities which are weighted for economic significance and market liquidity. To promote diversification, weighting restrictions are placed on individual commodities and commodity groups.

MSCI EAFE (Europe, Australasia, Far East): A free float-adjusted market capitalization index that is designed to measure developed market equity performance, excluding the United States and Canada. The EAFE consists of the country indices of 21 developed nations.

**MSCI EAFE Growth:** Represents approximately 50% of the free float-adjusted market capitalization of the MSCI EAFE index, and consists of those securities classified by MSCI as most representing the growth style.

**MSCI EAFE Small Cap:** Offer an exhaustive representation of this size segment by targeting companies that are in the Investable Market Index but not in the Standard Index in a particular developed market. The indices include Value and Growth style indices and industry indices based on the Global Industry Classification Standard (GICS).

**MSCI EAFE Value:** Represents approximately 50% of the free float-adjusted market capitalization of the MSCI EAFE index, and consists of those securities classified by MSCI as most representing the value style.

**MSCI Emerging Markets:** A free float-adjusted market capitalization index that is designed to measure equity market performance of emerging markets. As of July 2, 2014, the index consists of the following 23 emerging market country indices: Brazil, Chile, China, Colombia, Czech Republic, Egypt, Greece, Hungary, India, Indonesia, Korea, Malaysia, Mexico, Peru, the Philippines, Poland, Qatar, Russia, South Africa, Taiwan, Thailand, Turkey, and the United Arab Emirates.

**Russell 2000:** Measures the performance of the 2,000 smallest companies in the Russell 3000 Index, which represent approximately 10% of the total market capitalization of the Russell 3000 Index.

**Russell Mid-cap:** Measures the performance of the 800 smallest companies of the Russell 1000 Index, which represent approximately 31% of the total market capitalization of the Russell 1000 Index.

**Standard & Poor's 500 (S&P 500):** Measures changes in stock market conditions based on the average performance of 500 widely held common stocks. Represents approximately 68% of the investable U.S. equity market.

**The Dow Jones Global Select REIT Index:** Intends to measure the performance of publicly traded real estate securities. The indices are designed to serve as proxies for direct real estate investment, in part by excluding companies whose performance June be driven by factors other than the value of real estate. This index represents equity real estate investment trusts (REITs) and real estate operating companies (REOCs) traded globally.

#### **DEFINITIONS:**

Small-cap stocks refers to a company's capitalization as determined by the total market value of its publicly traded shares.

Large-cap stocks are generally defined as those with market capitalizations of more than \$10 billion.

**Energy sector** is a category of stocks that relate to producing or supplying energy.

**Commodity** is a basic good used in commerce that is interchangeable with other commodities of the same type. **Commodities** are most often used as inputs in the production of other goods or services.

**Fixed income** is a type of investment in which real return rates or periodic income is received at regular intervals and at reasonably predictable levels.

**High-yield bond** is a high paying bond with a lower credit rating than investment-grade corporate bonds, Treasury bonds and municipal bonds.

**International:** This asset class represents managers that seek long term capital appreciation by investing primarily in companies outside of the United States, including emerging markets in some instances. Companies of all cap sizes June be considered.
